

# THE FELLOWS OF THE IBF

Created in 1983, the Fellows program consists of a special group of lawyers and non-attorney Foundation supporters who have committed, by direct payment or pledge over ten years, sums of money ranging from \$1,000 to \$25,000 to help fund the Foundation's grants programs and assist lawyers in need.

## HOW IT WORKS



Fellows can make monthly, quarterly, or annual payments.

*Monthly payments start at \$100 a year or less than \$9 a month!*



All Fellows payments may be restricted for the appellate district of your choice, allowing your contributions to stay close to home.



All previous Fellows payments count toward your upgraded pledge balance.

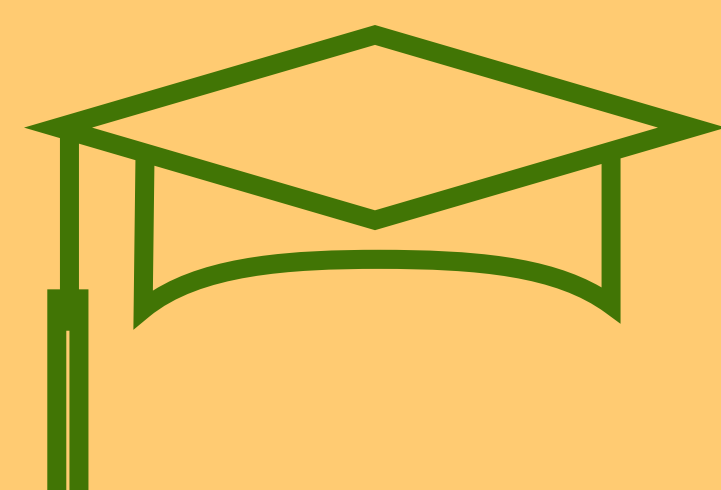

### POST-GRADUATE LEGAL FELLOWSHIPS



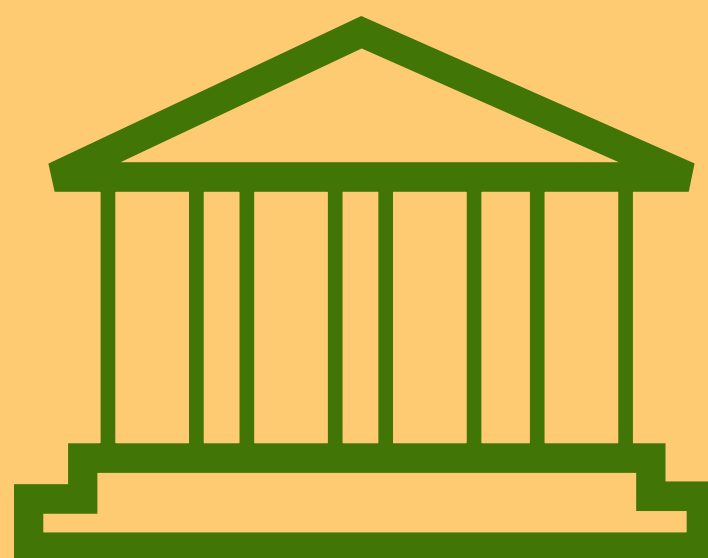
